540400 FOUND A 1 INCH IRON PIPE AND TAG STAMPED "RCE 27104" PER R2, 4 INCHES ABOVE THE GROUND ENCIrcLED BY A COLLAR OF STONES. ALSO FOUND A 'T' POST WITH AN 8 FOOT TALL BY 2.5 INCH DIAMETER PVC SLEEVE 0.8 FEET NORTHERLY OF THE MONUMENT. ACCEPTED SAID PIPE AS THE TRUE CORNER AND REPLACED WITH A STANDARD US FOREST SERVICE ALUMINUM MONUMENT WITH A 3/4 INCH DIAMETER ALUMINUM CAP, STAMPED AS SHOWN, ON A 2 1/2 INCH DIAMETER POST, 30 INCHES LONG, 26 INCHES IN THE GROUND, ENCIrcLED BY A SMALL COLLAR OF STONES. PLACED A PLASTIC ENCASED MAGNET BENEATH THE MONUMENT. BURIED THE FOUND 1 INCH IRON PIPE UPSIDE DOWN ALONGSIDE THE NEW MONUMENT. SET A U CHANNEL ALUMINUM POST WITH A FOREST SERVICE 54-9 MONUMENT SIGN AND A FOREST SERVICE 54-2 BOUNDARY SIGN, 1.0 FOOT WESTERLY. NO ORIGINAL OR NEW BEARING TREES IN THE VICINITY.

FOUND SAID PIPE TO BE N49°11'E, 0.91' FROM THE TRUE CORNER. LEFT SAID PIPE IN PLACE AND SET NOTHING AT THE TRUE CORNER.

PLACED A PLASTIC ENCASED MAGNET BENEATH THE MONUMENT. BURIED THE FOUND 1 INCH IRON PIPE UPSIDE DOWN ALONGSIDE THE NEW MONUMENT. SET A U CHANNEL ALUMINUM POST WITH A FOREST SERVICE 54-9 MONUMENT SIGN AND A FOREST SERVICE 54-2 BOUNDARY SIGN, 1.0 FOOT WESTERLY. NO ORIGINAL OR NEW BEARING TREES IN THE VICINITY.

ACCEPTED SAID PIPE AS THE TRUE CORNER AND REPLACED WITH A STANDARD US FOREST SERVICE ALUMINUM MONUMENT WITH A 3/4 INCH DIAMETER ALUMINUM CAP, STAMPED AS SHOWN, ON A 2 1/2 INCH DIAMETER POST, 30 INCHES LONG, 24 INCHES IN THE GROUND, ENCIrcLED BY A MOUND OF STONES, 2.0 FEET IN DIAMETER AND 6 INCHES ABOVE THE GROUND. ACCEPTED SAID PIPE AS THE TRUE CORNER AND REPLACED WITH A STANDARD US FOREST SERVICE ALUMINUM MONUMENT WITH A 3/4 INCH DIAMETER ALUMINUM CAP, STAMPED AS SHOWN, ON A 2 1/2 INCH DIAMETER POST, 30 INCHES LONG, 26 INCHES IN THE GROUND, ENCIrcLED BY A MOUND OF STONES, 3.5 FEET IN DIAMETER AND 4 INCHES ABOVE THE GROUND. AT THE TRUE CORNER, SET A STANDARD US FOREST SERVICE ALUMINUM MONUMENT WITH A 3/4 INCH DIAMETER ALUMINUM CAP, STAMPED AS SHOWN, ON A 2 1/2 INCH DIAMETER POST, 30 INCHES LONG, 26 INCHES IN THE GROUND, ENCIrcLED BY A MOUND OF STONES, 1.5 FEET IN DIAMETER AND 4 INCHES ABOVE THE GROUND.
